NOTICE TO EXHIBITORS

If because of **RIOTS, WARS, STRIKES, CIVIL DISTURBANCES, NATIONAL EMERGENCIES, AND THE DICTATES OF LAW ENFORCEMENT OR THE OWNER OF THE GROUNDS/FACILITY**, or other acts beyond the control of the management to open or complete the event, no refund of entry fees will be made.

THE TRIAL WILL BE OPEN from 7:30 a.m. to 7:00 p.m.

AS SPECIFIED IN CHAPTER 12, SECTION 4 of the AKC Rules Applying to Dog Shows, information contained on the entry form is required to be published in the club's show catalog. This information is also subject to publication in other media.

DOGS MAY ARRIVE any time prior to their scheduled time of judging. **Dogs not required for further judging will be excused.**

JUDGES WILL NOT WAIT FOR ANY DOG HOLDING UP A CLASS. Owners or agents alone are responsible for the presence of their dogs in the judging ring when their classes are called to be judged.

JUDGING PROCEDURES may be modified to accommodate disabled handlers.

ALL DOGS PRESENT must be held on a leash or confined to their crates except when being judged or when in the exercise area.

Please use the **CLEARLY MARKED AREAS FOR DOG BREAKS**. No other areas outside of the signed areas, nor any of the adjacent properties, may be used for elimination. Please be considerate and clean up after your dog and be sure to use the designated outdoor collection receptacles marked "BREAK AREAS".

UNENTERED DOGS will not be permitted in the building as space is limited. Thank you for respecting this.

NO EX-PENS are permitted on the premises. **NO WIRE CRATES** on matted areas. Please bring your own chairs. Crates and chairs will be placed in properly designated areas only. Please be considerate of other exhibitors needing crate space or warming up to go into the ring.

NO GROOMING TABLES inside the building.

ABSOLUTELY NO SMOKING OR VAPING IN THE BUILDING.

REFUND FOR A BITCH IN SEASON pulled after the closing date will be processed after being presented with a letter from the bitch's vet stating she is in season. There will be a \$5.00 handling charge for each dog per trial.

FOOD CONCESSIONS will NOT be for sale at this trial. There are a number of fast food restaurants and eateries close by the show site.

CONSULT JUDGING PROGRAM for time of judging.

REFUND CHECKS are void after 180 days and will NOT be re-issued.

THE TRIAL COMMITTEE will use due care and diligence for the welfare of dogs and exhibitors, but will not be responsible for, nor assume any liability in the event of an accident or misfortune to either dogs or exhibitors participating in this trial. **THE GLOUCESTER COUNTY KENNEL CLUB AND LCCDTC WILL NOT BE HELD RESPONSIBLE FOR ANY ACCIDENT** that may occur to any person, animal, property or vehicle. The exhibitors shall hold the Trial Committee harmless and indemnify it against any legal proceeding arising from any accident, nor will either party be responsible for damage to vehicles or loss of personal property.

NO GASOLINE OR DIESEL GENERATORS are permitted inside any building or within 100 feet of any building in which this dog show is conducted.

NO OVERNIGHT CAMPING/RV is permitted on this trial site.

NO DOGS MAY BE LEFT OVERNIGHT in the buildings.

THERE WILL NOT BE AN OFFICIAL PHOTOGRAPHER available at this trial.

FREE ADMISSION & PARKING. You must **PARK IN DESIGNATED AREAS ONLY**.
